IMPORTANT:

- ▶ Payment must be received by the Pay By date. If payment is not received by this date the vessel will be unregistered and will not be able to enter or be operated on NSW State waters.
- ▶ The registration number must be displayed on both sides of the vessel, in figures at least 150mm high (for PWC and sailing vessels 100mm) in a contrasting colour to the hull so that they are clearly distinguishable. Sailing vessels may display the registration number on the transom
- ▶ Marine accidents involving a vessel must be promptly reported in writing
- ▶ Owners of a PWC must ensure that only the holders of a valid PWC licence drive the PWC
- ▶ Payment must be made before this registration is valid.
