

The Boats and Vessels (Registration, Speed Limits and Abatement of Noise), Ordinances, 1970 and 1994

Section 3(3)(b) of the above Ordinance requires that all transfers ownership or shares in ownership of a registered boat shall be notified to Guernsey Harbours within 28 days.

Section 3(3)(e) of the above Ordinance requires that if any boat is wrecked, broken up or permanently removed from the island, notification shall be made to Guernsey Harbours within 28 days.

REQUIREMENTS AS TO NUMBERS

Except in the case of registered fishing boats, the registered number shall be painted or marked on the exterior of the hull at the transom or the extreme after end of the boat but in the case of a personal watercraft/jet ski, on both left and right sides of the fore deck

(a) Boats other than speedboats

 The number shall be of a distinctive colour compared with the colour of the hull and each numeral of the number shall be at least one and one half inches and not more than two inches high.

(b) Personal watercraft/jet skis

 The number shall be of a distinctive colour compared with the colour of the surrounding background and each numeral of the number shall be at least six inches high.

(c) Speedboats

- The number shall be black on a white background.
- Each numeral of the number shall be at least six inches high and each part thereof shall be at least one and one quarter inches broad.
- Except in the case of the numeral '1' the total width of the space taken by each numeral shall be at least three inches.
- The space between the nearest parts of each numeral shall be at least one inch.
- 5. There shall be a margin of at least three inches between the nearest part of each numeral and the top and bottom of the white background on which the number appears and of at least two inches between the nearest parts of each numeral and the sides of such background.

The Vessels and Speedboats (Compulsory Third-Party Insurance, Mooring Charges and Removal of Boats) (Guernsey) Law, 1972 (as amended)

A person shall not use, or cause to permit any other person to use, in the territorial waters of the Islands a speedboat or personal water craft (which expression shall mean any boat commonly known as a jet ski, wet bike, water scooter or fun craft or by any other like description and any other power-driven boat steered by means handlebar operated linkage system or by altering the relationship between the body weight of any person on the boat and the boat itself) unless there is in force in relation to the user of that speedboat (or personal water craft) by that person or that other person, as the case may be, a policy of insurance issued by an authorised insurer, the policy being one which, subject to any restrictions or conditions specified therein, insures such person or classes of persons as may be specified in the policy in respect of any liability which may be incurred by him or them in respect of the death of or bodily injuty to any person or for loss of or any damage to any property in the water or on the foreshore in any one ocurrence or series of ocurrences arising out of any one event, caused by or arising out of the use of that speedboat (or personal water craft) other than when towing a person engaged in water ski-ing, aqua-planing or similar sport.
